That if for any reasons not beyond the control of either the student or the guarantor the student or the guarantor the student fails to pursue his/ her studies at the said school before appearing for selection for entry to any institutions as may from time to time be prescribed by the Governors for training for entry to the Regular Armed Forces or fails to appear for the said selection or in the event of his/ her not succeeding in the said selection, fails to reappear for selection, till such time as his/ her age permits him/ her to do so, according to the rules and regulations.

For the time being in force or having been declared successful at the said selection does not proceed to one of the said Institutions to which he/ she may be directed to proceed for being trained for entry into the Regular Armed Forces or having joined the said institutions fails to complete the training there at for the entry into the Regular Armed Forces or fails to join the Regular Armed Forces after completing the training at the said Institution, then and if any such case the guarantor shall forth – with pay to the Governors in cash the sum the students has received from the School and / or the State Government / Central Government the value of the scholarships he has received for the period the students was at the said school.
